| <ol style="list-style-type: none"> <li>1. <b>NO</b> tires, batteries, or motor oil.</li> <li>2. <b>NO</b> paint cans, including spray paint cans.</li> <li>3. <b>NO</b> chemicals of any kind.</li> <li>4. <b>NO</b> household garbage.</li> <li>5. <b>NO DOUBLE AXLE TANDEM TRAILERS.</b></li> <li>6. <b>NO</b> construction or remodeling materials, i.e. roofing, wood, shingles, sheetrock, carpet, carpet padding, siding, laminate flooring, toilet, tub, etc.</li> <li>7. <b>NO</b> concrete or brick.</li> <li>8. <b>NO</b> grass clippings, leaves, or pine straw, mulch/dirt</li> <li>9. <b>NO</b> licensed vehicles (motorcycles, scooter, etc.)</li> <li>10. Large objects (i.e. swing set or camper covers must be dismantled before dumping.</li> </ol> | <ol style="list-style-type: none"> <li>11. 55-gallon drums with lids or without lids are <b>NOT</b> accepted.</li> <li>12. All nails, screws and hardware <b>MUST</b> be removed from fencing materials.</li> <li>13. Tree limbs must be less than (6) six inches in diameter and no longer than (6) six feet in length.</li> <li>14. Tree limbs must be unloaded in the proper dump area, and all fencing <b>MUST</b> be placed inside the proper dumpster.</li> <li>15. Constituents are limited to <b>ONE LOAD</b> per day.<br/>       * <b>MUST remove</b> compressors from freezers and refrigerators before dumpster use<br/>       *<b>NO</b> Boxes</li> </ol> |
